- 5 SEC. 2. PILOT PROGRAM TO PROVIDE EDUCATIONAL AS-
- 6 SISTANCE TO PHYSICIAN ASSISTANTS TO BE
- 7 EMPLOYED AT THE DEPARTMENT OF VET-
- 8 ERANS AFFAIRS.
 - (a) Pilot Program.—
- 10 (1) In General.—The Secretary of Veterans
- Affairs shall carry out a pilot program to be known
- as the "Grow Our Own Directive" or "G.O.O.D."
- pilot program (in this section referred to as the
- 14 "pilot program") to provide educational assistance
- to certain former members of the Armed Forces for
- 16 education and training as physician assistants of the
- 17 Department of Veterans Affairs.
- 18 (2) Information on Pilot Program.—The
- 19 Secretary shall provide information on the pilot pro-
- gram to eligible individuals under subsection (b), in-
- 21 cluding information on application requirements and
- a list of entities with which the Secretary has
- partnered under subsection (g).
- (b) Eligible Individual is eligi-
- 25 ble to participate in the pilot program if the individual—

1	(1) has medical or military health experience
2	gained while serving as a member of the Armed
3	Forces;
4	(2) has received a certificate, associate degree,
5	baccalaureate degree, master's degree, or
6	postbaccalaureate training in a science relating to
7	health care;
8	(3) has participated in the delivery of health
9	care services or related medical services, including
10	participation in military training relating to the
11	identification, evaluation, treatment, and prevention
12	of diseases and disorders; and
13	(4) does not have a degree of doctor of medi-
14	cine, doctor of osteopathy, or doctor of dentistry.
15	(e) Duration.—The pilot program shall be carried
16	out during the five-year period beginning on the date that
17	is 180 days after the date of the enactment of this Act.
18	(d) Selection.—
19	(1) IN GENERAL.—The Secretary shall select
20	not less than 250 eligible individuals under sub-
21	section (b) to participate in the pilot program.
22	(2) Priority for selection.—In selecting in-
23	dividuals to participate in the pilot program under
24	paragraph (1), the Secretary shall give priority to
25	the following individuals:

1	(A) Individuals who participated in the In-
2	termediate Care Technician Pilot Program of
3	the Department that was carried out by the
4	Secretary between January 2011 and February
5	2015.
6	(B) Individuals who agree to be employed
7	as a physician assistant for the Veterans Health
8	Administration at a medical facility of the De-
9	partment located in a community that—
10	(i) is designated as a medically under-
11	served population under section
12	330(b)(3)(A) of the Public Health Service
13	Act $(42 \text{ U.S.C. } 254b(b)(3)(A))$; and
14	(ii) is in a State with a per capita
15	population of veterans of more than 9 per-
16	cent according to the National Center for
17	Veterans Analysis and Statistics and the
18	United States Census Bureau.
19	(e) Educational Assistance.—
20	(1) In general.—In carrying out the pilot
21	program, the Secretary shall provide educational as-
22	sistance to individuals participating in the pilot pro-
23	gram, including through the use of scholarships, to
24	cover the costs to such individuals of obtaining a

5 1 master's degree in physician assistant studies or a 2 similar master's degree. 3 (2) Use of existing programs.—In pro-4 viding educational assistance under paragraph (1), 5 the Secretary shall use the Department of Veterans 6 Affairs Health Professionals Educational Assistance Program under chapter 76 of title 38, United States 7 8 Code, and such other educational assistance pro-9 grams of the Department as the Secretary considers 10 appropriate. 11 (3) Use of scholarships.—The Secretary 12 shall provide not less than 35 scholarships under the 13 pilot program to individuals participating in the pilot 14 program during each year in which the pilot pro-15 gram is carried out. 16 (f) Period of Obligated Service.— 17 (1) In General.—The Secretary shall enter 18

(1) In General.—The Secretary shall enter into an agreement with each individual participating in the pilot program in which such individual agrees to be employed as a physician assistant for the Veterans Health Administration for a period of obligated service specified in paragraph (2).

(2) Period specified.—With respect to each individual participating in the pilot program, the pe-

1	riod of obligated service specified in this paragraph
2	for the individual is—
3	(A) if the individual is participating in the
4	pilot program through a program described in
5	subsection (e)(2) that specifies a period of obli-
6	gated service, the period specified with respect
7	to such program; or
8	(B) if the individual is participating in the
9	pilot program other than through a program
10	described in such subsection, or if such program
11	does not specify a period of obligated service, a
12	period of three years or such other period as
13	the Secretary considers appropriate for pur-
14	poses of the pilot program.
15	(g) Breach.—
16	(1) Liability.—Except as provided in para-
17	graph (2), an individual who participates in the pilot
18	program and fails to satisfy the period of obligated
19	service under subsection (f) shall be liable to the
20	United States, in lieu of such obligated service, for
21	the amount that has been paid or is payable to or
22	on behalf of the individual under the pilot program,
23	reduced by the proportion that the number of days

served for completion of the period of obligated serv-

1	ice bears to the total number of days in the period
2	of obligated service of such individual.
3	(2) Exception.—If an individual is partici-
4	pating in the pilot program through a program de-
5	scribed in subsection (e)(2) that specifies a period of
6	obligated service, the liability of the individual for
7	failing to satisfy the period of obligated service
8	under subsection (f) shall be determined as specified
9	with respect to such program.
10	(h) Mentors.—The Secretary shall ensure that a
11	physician assistant mentor or mentors are available for in-
12	dividuals participating in the pilot program at each facility
13	of the Veterans Health Administration at which a partici-
14	pant in the pilot program is employed.
15	(i) Partnerships.—In carrying out the pilot pro-
16	gram, the Secretary shall seek to partner with the fol-
17	lowing:
18	(1) Not less than 15 institutions of higher edu-
19	cation that—
20	(A) offer a master's degree program in
21	physician assistant studies or a similar area of
22	study that is accredited by the Accreditation
23	Review Commission on Education for the Phy-
24	sician Assistant; and
25	(B) agree—

(i) to guarantee seats in such master's
degree program for individuals partici-
pating in the pilot program who meet the
entrance requirements for such master's
degree program; and
(ii) to provide individuals partici-
pating in the pilot program with informa-
tion on admissions criteria and the admis-
sions process.
(2) Other institutions of higher education that
offer programs in physician assistant studies or
other similar areas of studies that are accredited by
the Accreditation Review Commission on Education
for the Physician Assistant.
(3) The Transition Assistance Program of the
Department of Defense.
(4) The Veterans' Employment and Training
Service of the Department of Labor.
(5) Programs carried out under chapter 41 of
title 38, United State Code, for the purpose of mar-
keting and advertising the pilot program to veterans
and members of the Armed Forces who may be in-
terested in the pilot program.
(j) Administration of Pilot Program.—For pur-
poses of carrying out the pilot program, the Secretary

1	shall appoint or select within the Office of Physician As-
2	sistant Services of the Veterans Health Administration the
3	following:
4	(1) A Deputy Director for Education and Ca-
5	reer Development of Physician Assistants who—
6	(A) is a physician assistant, a veteran, and
7	employed by the Department as of the date of
8	the enactment of this Act;
9	(B) is responsible for—
10	(i) overseeing the pilot program;
11	(ii) recruiting candidates to partici-
12	pate in the pilot program;
13	(iii) coordinating with individuals par-
14	ticipating in the pilot program and assist-
15	ing those individuals in applying and being
16	admitted to a master's degree program
17	under the pilot program; and
18	(iv) providing information to eligible
19	individuals under subsection (b) with re-
20	spect to the pilot program; and
21	(C) may be employed in the field at a med-
22	ical center of the Department.
23	(2) A Deputy Director of Recruitment and Re-
24	tention who—

1	(A) is a physician assistant, a veteran, and
2	employed by the Department as of the date of
3	the enactment of this Act;
4	(B) is responsible for—
5	(i) identifying and coordinating the
6	needs of the pilot program and assist the
7	Secretary in providing mentors under sub-
8	section (h) to participants in the pilot pro-
9	gram; and
10	(ii) coordinating the staff of facilities
11	of the Veterans Health Administration
12	with respect to identifying employment po-
13	sitions and mentors under subsection (h)
14	for participants in the pilot program; and
15	(C) may be employed in the field at a med-
16	ical center of the Department.
17	(3) A recruiter who—
18	(A) reports directly to the Deputy Director
19	of Recruitment and Retention; and
20	(B) works with the Workforce Manage-
21	ment and Consulting Office and the Healthcare
22	Talent Management Office of the Veterans
23	Health Administration to develop and imple-
24	ment national recruiting strategic plans for the

1	recruitment and retention of physician assist-
2	ants within the Department.
3	(4) An administrative assistant, compensated at
4	a rate not less than level GS-6 of the General
5	Schedule, or equivalent, who assists with administra-
6	tive duties relating to the pilot program in the Office
7	of Physician Assistant Services and such other du-
8	ties as determined by the Secretary to ensure that
9	the Office runs effectively and efficiently.
10	(k) Report.—
11	(1) In general.—Not later than one year
12	after the date of the enactment of this Act, the Sec-
13	retary of Veterans Affairs, in collaboration with the
14	Secretary of Labor, the Secretary of Defense, and
15	the Secretary of Health and Human Services, shall
16	submit to Congress a report on the pilot program.
17	(2) Elements.—The report required by para-
18	graph (1) shall include the following:
19	(A) The extent to which the pilot program
20	is effective in improving the ability of eligible
21	individuals under subsection (b) to become phy-
22	sician assistants;
23	(B) An examination of whether the pilot
24	program is achieving the goals of—

1	(i) enabling individuals to build on
2	medical skills gained as members of the
3	Armed Forces by entering into the physi-
4	cian assistant workforce of the Depart-
5	ment; and
6	(ii) helping to meet the shortage of
7	physician assistants employed by the De-
8	partment.
9	(C) An identification of such modifications
10	to the pilot program as the Secretary of Vet-
11	erans Affairs, the Secretary of Labor, the Sec-
12	retary of Defense, and the Secretary of Health
13	and Human Services consider necessary to meet
14	the goals described in subparagraph (B).
15	(D) An assessment of whether the pilot
16	program could serve as a model for other pro-
17	grams of the Department to assist individuals
18	in obtaining certification and employment in
19	other health care fields.
20	(l) Source of Amounts.—Not less than \$8,000,000
21	of the amount necessary to carry out the pilot program
22	shall be derived from amounts appropriated to the Depart-
23	ment of Veterans Affairs before the date of the enactment
24	of this Act.

1	SEC. 3. ESTABLISHMENT OF STANDARDS FOR THE DEPART-
2	MENT OF VETERANS AFFAIRS FOR USING
3	EDUCATIONAL ASSISTANCE PROGRAMS TO
4	EDUCATE AND HIRE PHYSICIAN ASSISTANTS.
5	(a) In General.—The Secretary of Veterans Affairs
6	shall establish standards described in subsection (b) to im-
7	prove the use by the Department of Veterans Affairs of
8	the Department of Veterans Affairs Health Professionals
9	Educational Assistance Program under chapter 76 of title
10	38, United States Code, and other educational assistance
11	programs of the Department, including the pilot program
12	under section 2, to educate and hire physician assistants
13	of the Department.
14	(b) STANDARDS.—The standards described in this
15	subsection are the following:
16	(1) Holding directors of medical centers of the
17	Department accountable for failure to use the edu-
18	cational assistance programs described in subsection
19	(a) and other incentives—
20	(A) to advance employees of the Depart-
21	ment in their education as physician assistants;
22	and
23	(B) to improve recruitment and retention
24	of physician assistants.
25	(2) Ensuring that the Department of Veterans
26	Affairs Education Debt Reduction Program under

1	subchapter VII of chapter 76 of such title is avail-
2	able for participants in the pilot program under sec-
3	tion 2 to fill vacant physician assistant positions at
4	the Department, including by—
5	(A) including in all vacancy announce-
6	ments for physician assistant positions the
7	availability of the Education Debt Reduction
8	Program; and
9	(B) informing applicants to physician as-
10	sistant positions of their eligibility for the Edu-
11	cation Debt Reduction Program.
12	(3) Monitoring compliance with the application
13	process for educational assistance programs de-
14	scribed in subsection (a) to ensure that such pro-
15	grams are being fully utilized to carry out this sec-
16	tion.
17	(4) Creating programs, including through the
18	use of the Department of Veterans Affairs Employee
19	Incentive Scholarship Program under subchapter VI
20	of chapter 76 of such title, to encourage employees
21	of the Department to apply to accredited physician
22	assistant programs.
23	(c) REGULATIONS.—The Secretary shall prescribe
24	such regulations as the Secretary considers appropriate to
25	carry out this section.

1	SEC. 4. ESTABLISHMENT OF PAY GRADES FOR PHYSICIAN
2	ASSISTANTS OF THE DEPARTMENT OF VET-
3	ERANS AFFAIRS AND REQUIREMENT TO PRO-
4	VIDE COMPETITIVE PAY.
5	(a) Establishment of Pay Grades.—Section
6	7404(b) of title 38, United States Code, is amended by
7	adding at the end the following:
	"PHYSICIAN ASSISTANT SCHEDULE "Physician Assistant III. "Physician Assistant II. "Physician Assistant II. "Physician Assistant I.".
8	(b) Competitive Pay.—Section 7451(a)(2) of such
9	title is amended—
10	(1) by redesignating subparagraph (B) as sub-
11	paragraph (C);
12	(2) by inserting after subparagraph (A) the fol-
13	lowing new subparagraph (B):
14	"(B) Physician assistant."; and
15	(3) in subparagraph (C), as redesignated by
16	paragraph (1), by striking "and registered nurse"
17	and inserting "registered nurse, and physician as-
18	sistant".
19	(e) National Strategic Plan.—
20	(1) In General.—The Secretary of Veterans
21	Affairs shall implement a national strategic plan for
22	the retention and recruitment of physician assistants
23	of the Department of Veterans Affairs that includes

the establishment and adoption of standards for the provision of competitive pay to physician assistants of the Department in comparison to the pay of physician assistants in the private sector.

(2) Report.—Not later than one year after the

date of the enactment of this Act, the Secretary shall submit to the Committee on Veterans' Affairs of the Senate and the Committee on Veterans' Affairs of the House of Representatives a report on the implementation of the national strategic plan under paragraph (1).
